1 Opening Remarks

2.1 Reading of the anti-trust statement

Mike Garl read the following statement aloud to the assembly:

ESTA and its members take seriously their obligation to comply with all applicable antitrust laws. Therefore, during this meeting and during all ESTA events, all discussions will be limited to those subjects that are permitted by the antitrust laws. All members should refrain from any discussion or mention of competitively sensitive subjects such as the current or future prices charged for any member product or services, current or future marketing plans or strategies, and current or future costs, including employee salaries. There also must be no agreement on the suppliers or customers that members will or will not do business with or the markets in which members will conduct business.

Violations of the antitrust laws can have serious consequences. If you have any questions or concerns about anything that is discussed at an ESTA meeting, please bring your concern to ESTA management. An easy to read pamphlet describing the antitrust laws is available from the ESTA staff.

Richard held up the pamphlet.

2.2 Reading of the call for patents

Mike Garl read the following statement aloud to the assembly:

ESTA intends not to publish any standard that contains protected intellectual property, unless that information can be licensed by anyone for a reasonable fee. ESTA uses a process of open patent and copyright disclosures to implement its intent. ESTA does not conduct patent or copyright searches and does not warrant that its standards contain no protected intellectual property.

In keeping with the open disclosures policy, I ask if anyone present wishes to notify this working group of the existence of a patent, patent application, copyright, or other protected intellectual property that might protect material in a standard being developed by this working group. You need not be the holder of the patent or copyright to notify this working group of its existence.

Karl Reported. Erin Grabe has applied to represent ESTA on 1126 and 160 to replace Larry Schoeneman, who has retired. Her application has been accepted and is pending approval at the April NFPA Standards Council meeting.

7 New business

7.1 TSP Participation Fee increase

ESTA's Executive Director and the Technical Standards Manager ask the TSC to consider a TSP fee increase, effective for all incoming new applications after January's meeting cycle.

Erin Grabe asked for the TSP's opinion on this – should it go up, and – if so – by how much? She said the fee was implemented in 2016. Bill Sapsis asked how difficult it's been to collect. Richard said it's been challenging but is now easier because it's written into the P&P.

Mike Lay suggested \$125 for this year, \$150 next year. Alan Rowe moved to do so, but withdrew the motion.

Bill Sapsis moved to approve a fee increase to \$150 in 2025. The motion was seconded. The motion carried with one objection from Alan Rowe, and no abstentions.

Mike Skinner suggested we note how long the fee has remained at \$100. Bill suggested marketing it as a \$50 increase, not as a 50% increase. The consensus was that we should bundle this with a fund-raising campaign targeted at supporting the TSP, which runs at a deficit.

Justin Bennett gave a summary report of the working group meeting. There are currently two active projects: 19-pin connectors in conjunction with related proposed changes to NEC, and Canadian Electrical Practices in Entertainment, which also has ESWG members participating.

Erin Grabe thanked the TSC for their swift action in pushing ES1.5 back to the working group. They had serious and productive discussions about the draft standard at the ESWG meeting.

8.2.1 ASTC

Andy Gibbs said there was nothing to report.

8.2.2 Event Safety Alliance

Erin Grabe said they are still planning their Event Safety Summit for the end of year, maybe in Houston, still TBD.

8.2.3 NFPA

8.2.3.1 FDW-AAA committee (NFPA 80 fire doors & fire safety curtains)

8.2.3.2 SPE-AAA (NFPA 160 & 1126, flame and pyrotechnics)

Karl said there's nothing much to report, their last meeting revealed nothing of concern, they're more interested with enforcement than ultimate safety. He said that the most recent meeting dealt with the process for AHJs to approve gas flame effects. He did not see it negatively affecting our industry.

8.2.3.3 SAF-AXM & BLD (assembly occupancies. NFPA 101, 102, & 5000)

Karl Ruling said that there is a meeting coming up at the end of February to deal with grandstands (NFPA 102). He did not see any problems looming for our industry.

8.2.3.4 NEC (NFPA 70)

Mitch Hefter reported, and submitted a report by email, which said:

The NEC Public Input meetings for the 2026 cycle were held January 15 – 26 in Charleston, SC. Topics of most interest to our constituency were mostly successful. Note that the code panel actions in these meetings are essentially staw polls, requiring only > 50% to pass. Those actions will be balloted (letter ballots) requiring a 2/3 vote in favor to be incorporated into a first draft of the 2026 edition. The biggest disappointment was our (my) effort to put pointers for definitions now located in Article 100 at the front of the Code into the appropriate articles failed.

Most proposals to add more requirements on Cybersecurity into the NEC – an installation Code, failed. Jason Potterf reports that many of these could be considered for NFPA 70B, a maintenance based standard. Most proposals for addition of Class 4 requirements failed.

The proposal for revision to 520.68 to more properly address multi-pin connectors was successful, with a new information note referring to E1.80. (If E1.80 is not complete by publishing date, the note would be removed). References to ESTA standards have been updated for the most recent revisions.

The biggest change coming, but for 2029, is a complete restructuring of the Code grouping articles more specifically related. Part of this comes from a desire to clear up distinctions with medium voltage as well as a merging of Chapter 8 communication systems into the resto of the Code. An appendix showing the numbering changes would appear in the 2026 edition. Most content will not change, it will just be located differently (e.g., Article 520 will become Article 1620). As disruptive as this seems, it actually does make sense.

The first draft will be available July 10, 2024, with the comment period ending August 28. Note that any proposals that wer rejected (resolved in NFPA language) will not be shown in the first draft but are available for Public Comment.

8.2.3.5 NFPA 70E

Mitch Hefter said it will be open for public input soon.

8.2.4 **USITT**

Mitch Hefter reproted. The conference is coming in March. Karl Ruling will receive a very distinguished award.

8.2.5 ICC

There is a proposal in the current 2027 IFC change cycle that updates the ANSI E1.21 reference and adds the ANSI ES1.7 (Weather Preparedness) standard to the IFC, coordinating with the most recent additions for same in the 2024 IBC. The FCAC has approved the change proposal and is listed as a proponent!

We're trying to good work, and seem to be successful, said Richard.

8.2.6 IES

Mitch Hefter said there is nothing to report. Erin Grabe asked if IES was ANSI accredited. Yes, said Mitch.

We have a tentative schedule, but no space assignments, so it's not yet possible to schedule the meetings. She also said it appears that we will be back in DFW for Fall meetings. 14-21 October, which may conflict with NEC meetings.
