### 1 Opening Remarks

Don Cooper called the meeting to order at 14:03, welcoming everyone to the meeting. He said that Marvin Lee Aday (also known by the pseudonym Meat Loaf) had passed away yesterday, possibly as a result of Covid, so it is yet another reminder of the unique times our industry is faced with. He asked everyone to please be careful and mindful of their own safety, and of the safety of others.

He said he intends to pause the work of some of the task groups in an effort to reassess progress, TG makeup, TG leadership, and possibly to implement new steps for quality assurance with our standards. He will communicate these changes directly to the task group leaders, where applicable, and he expects these changes to be implemented sometime over the next month, or so.

He said that he was amending the agenda slightly for today; he will receive regular progress reports on documents in development, but requested that no motions for action be made, for any document currently in development, other than the BSR ES1.18 Rigging draft.

### 2 Patent and anti-trust statements

#### 2.1 Reading of the anti-trust statement

Don Cooper read the following statement aloud to the assembly:

ESTA and its members take seriously their obligation to comply with all applicable antitrust laws. Therefore, during this meeting and during all ESTA events, all discussions will be limited to those subjects that are permitted by the antitrust laws. All members should refrain from any discussion or mention of competitively sensitive subjects such as the current or future prices charged for any member product or services, current or future marketing plans or strategies, and current or future costs, including employee salaries. There also must be no agreement on the suppliers or customers that members will or will not do business with or the markets in which members will conduct business.

Violations of the antitrust laws can have serious consequences. If you have any questions or concerns about anything that is discussed at an ESTA meeting, please bring your concern to ESTA management. An easy to read pamphlet describing the antitrust laws is available from the ESTA staff.

Karl Ruling held up the pamphlet in front of his camera, for all video-enabled attendees to see.

#### 2.2 Reading of the call for patents

Don Cooper read the following statement aloud to the assembly:

ESTA intends not to publish any standard that contains protected intellectual property, unless that information can be licensed by anyone for a reasonable fee. ESTA uses a process of open patent and copyright disclosures to implement its intent. ESTA does not conduct patent or copyright searches and does not warrant that its standards contain no protected intellectual property.

In keeping with the open disclosures policy, I ask if anyone present wishes to notify this working group of the existence of a patent, patent application, copyright, or other protected intellectual property that might protect material in a standard being developed by this working group. You need not be the holder of the patent or copyright to notify this working group of its existence.

Membership is open to all parties who are affected by the work of the group; membership in ESTA is not a requirement, but there is a \$100/person/year participation fee to help fund the costs of running the Technical Standards Program. Any principal member and alternate that both miss three consecutive meetings or that miss three consecutive letter ballots will have their membership status changed to observer. This action will be taken at the beginning of the first meeting after such inaction and will be recorded in the minutes of that meeting.

Alyxzander Bear reported. Richard Nix has the document doing cleanup from the initial round of TSC comments. He expected that when Richard was finished that the document would make another pass around the task group for final review. Richard said he was about 75% finished with the edits he was making, but that it would be returned to the task group with a considerable amount of work left to do, because there are many parts that are still unclear, and he is not making substantive changes – he is only helping clean up obvious editorial and grammatical errors noted by the TSC reviewers. He cannot make substantive changes to the document without their explicit approval to do so.

From the October meeting minutes:

Don Cooper said that it is time to begin considering what new projects should be taken on, now that we have several current projects either published or soon to be published. He asked everyone to bring their suggestions back to the January meeting.

### 7.2 New project request - Weapon safety

The TSC must approve new project requests, so it is on their meeting agenda, too.

Don Cooper asked about procedure. Richard Nix said that both the working group and the TSC must approve it – technically, the procedure is that the TSC first approves it then assigns the project to a working group. However, since this request came out of the ESWG, that would be the most likely place the TSC would send it. The working group can vote now, and the TSC has it on their agenda for consideration next Monday.

Ethan Gilsen reported that this was generated as a result of the recent "Rust" movie incident. He believes that our organization is the best forum to address this topic. It is also an opportunity to recruit subject matter experts from other industries. He made a motion to approve the project request. The motion was seconded. There was substantial discussion.

Steve Vanciel is licensed, and was the firearms master for Disney. He supports the project.

Jesse Chant said that there are legal requirements to consider, especially between Canada and the US. She asked if this project would address the legal aspects, or only address the "minute-by-minute" of when they are brought onsite to an event. She indicated her preference to be that it address only when they are brought on set.

Janet Sellery provided a link to the Ontario Guidelines for the working group's reference. Stage Combat/Stunts and Weaponry Safety Guideline for the Live Performance Industry in Ontario (this guideline is under revision) - https://www.labour.gov.on.ca/english/hs/pubs/liveperformance/gl\_live\_combat.php

Randall Greenlee noted that in Germany they have a 60-page document on weapons safety in the theatre. He thinks it is a good project.

Neal Huff said one of his clients manufacturers prop weapons, and may be a good resource.

Keith Sklar said there is an Actor's Equity guidance document that has evolved from an original guidelines document authored by the Society of American Fight Directors (SAFD).

Alyxzander Bear said that addressing the legal aspects may not be appropriate for this type of project, mainly because there is no single CCF (Concealed-Carry Firearms) permit good for all 50 states, not to mention the differences already noted in Canada.

Jesse Chant said she would like to see a training aspect in any document this group may decide to produce.

Mike Aug asked if the project scope could be better defined before it is approved, or could the motion stipulate such a thing. Don Cooper said that we can do what we think is appropriate with the scope.

Janine Jordan asked for clarity about what the motion entails – what are we voting on? Don Cooper said the motion is to accept a very broad-scope project, to clarify the scope if the project is approved. Mike Aug expressed concern that the scope is too broad.

Karl Ruling put the project scope up for everyone to see.

Don Cooper suggested that it isn't practical to try and refine the scope here, in the context of a large working

group. Mike Aug agreed and suggested that is a good reason to return the project request to the submitters for more clarity. Don Cooper disagreed with that suggestion, saying that he thought the scope was broad enough to allow us to modify it appropriately.

Steve Serafin said he is not against the standard, but he noted that we have a lot of start and stop presently, but thinks that the complexity of the subject matter, as exemplified by the extensive discussion, warranted not taking on the project at this time, but suggested it be assigned to an ad-hoc committee to investigate further.

Don Reminded everyone that the motion is simply to tell the TSC that we want to take on the project. He closed discussion, to call the question.

The motion carried with Steve Serafin, Mike Aug, Jesse Chant, and Steve Adelman opposed the motion. It will forward to the TSC for consideration.
