1 Opening Remarks

Don Cooper called the meeting to order at 09:06.

2 Patent and anti-trust statements

2.1 Reading of the anti-trust statement

Don Cooper read the following statement aloud to the assembly:

ESTA and its members take seriously their obligation to comply with all applicable antitrust laws. Therefore, during this meeting and during all ESTA events, all discussions will be limited to those subjects that are permitted by the antitrust laws. All members should refrain from any discussion or mention of competitively sensitive subjects such as the current or future prices charged for any member product or services, current or future marketing plans or strategies, and current or future costs, including employee salaries. There also must be no agreement on the suppliers or customers that members will or will not do business with or the markets in which members will conduct business.

Violations of the antitrust laws can have serious consequences. If you have any questions or concerns about anything that is discussed at an ESTA meeting, please bring your concern to ESTA management. An easy to read pamphlet describing the antitrust laws is available from the ESTA staff.

Richard Nix held up the pamphlet for all to see.

2.2 Reading of the call for patents

Don Cooper read the following statement aloud to the assembly:

ESTA intends not to publish any standard that contains protected intellectual property, unless that information can be licensed by anyone for a reasonable fee. ESTA uses a process of open patent and copyright disclosures to implement its intent. ESTA does not conduct patent or copyright searches and does not warrant that its standards contain no protected intellectual property.

In keeping with the open disclosures policy, I ask if anyone present wishes to notify this working group of the existence of a patent, patent application, copyright, or other protected intellectual property that might protect material in a standard being developed by this working group. You need not be the holder of the patent or copyright to notify this working group of its existence.

Nothing was revealed.

3 Attendance and Membership

3.1 Requirements for membership

Don Cooper read the following statement aloud to the assembly:

Membership is open to all parties who are affected by the work of the group; membership in ESTA is not a requirement, but there is a \$100/person/year participation fee to help fund the costs of running the Technical Standards Program. Voting members are required to attend meetings and vote on letter ballots. Any principal member and alternate that both miss three consecutive meetings or that miss three consecutive letter ballots will have their membership status changed to observer. This action will be taken at the beginning of the first meeting after such inaction and will be recorded in the minutes of that meeting.

Richard Nix reminded everyone that the TSP fee renewals had gone out in early February. Please act on them, or contact him if the email hasn't been received.

3.2 Determination of a quorum

There are now 37 voting members, so a quorum is 13; a supermajority is 19. [The number of voting members could change by as many as 6, in which case the count will be 43. q=15, s= 22]

Richard Nix confirmed, both requirements have been met.

Dominic Housiaux said the comment quality was very high, and that the engagement was appreciated.

7.1 New project request – Parade Safety

Steve Adelman moved to accept the project and start a new task group. The motion was seconded. There was discussion.

Chris Schmidt asked about scope. Steve Adelman explained that the scope would at the very least include front-of house requirements, but may also include operational aspects. Erin Grabe noted that there is already a parade float standard. Steve said the task group leader for that particular parade float standard is also slated to be on this task group. The motion carried without objection or abstention, and will forward to the TSC.

8 Other business and announcements

8.1 Event Safety Guide - 2nd edition

Erin Grabe asked Don Cooper about the second edition of the Event Safety Guide, and how it might impact our work. Don Cooper explained that the original intent was to be able to gather the body of published ES1 standards into what would become ESG 2nd Edition. After seeing how the development process works, they discovered that was not a reasonable goal, so they have changed direction somewhat.

Erin asked if a newer edition of the ESG would result in moving the baseline for task groups with works-inprogress. Steve Adelman said that it's intended to compile and distill, but now we have a better base to work from because of the standards that have been published – the content is essentially peer-reviewed.

Robert Haycock asked what the timeline for 2nd Edition would be. Steve Adelman said that there is no current timeline, although they have milestones in place. The next milestone is for John Badcock to do a first pass, return it to Steve Adelman and Steve Lemon, who will reformat as necessary before inviting teams of writers to begin building onto the base foundation. This might take about two years, but that might be optimistic.

Robert Haycock expressed his concern that the efforts be coordinated, so that there is consistency between the standards development work and the ESG 2nd revision.

Erin asked if there would be a public review, as with the first edition. Steve Adelman said yes, there will be a public review.
