1 Opening Remarks

Don Cooper called the meeting to order at 14:07. He thanked everyone for all of their hard work in all of the standards we have in progress. He was reminded of a movie called Planet 9 from Outer Space, directed by Edward Junior, and often described as the worst movie ever made. In the US it has become a very popular cult classic, yet it reminds us that even the worst things can have a humorous and positive outcome. He drew a comparison between it and his position as working group leader, saying that there is hope, and everyone's hard work on these standards is greatly appreciated!

2 Patent and anti-trust statements

2.1 Reading of the anti-trust statement

Don Cooper read the following statement aloud to the assembly:

ESTA and its members take seriously their obligation to comply with all applicable antitrust laws. Therefore, during this meeting and during all ESTA events, all discussions will be limited to those subjects that are permitted by the antitrust laws. All members should refrain from any discussion or mention of competitively sensitive subjects such as the current or future prices charged for any member product or services, current or future marketing plans or strategies, and current or future costs, including employee salaries. There also must be no agreement on the suppliers or customers that members will or will not do business with or the markets in

which members will conduct business.

Violations of the antitrust laws can have serious consequences. If you have any questions or concerns about anything that is discussed at an ESTA meeting, please bring your concern to ESTA management. An easy to read pamphlet describing the antitrust laws is available from the ESTA staff.

Richard Nix held up the pamphlet. Don Cooper said it would be nice to produce an ariline-style video of these required readings. He would like to do that for ESTA.

2.2 Reading of the call for patents

Don Cooper read the following statement aloud to the assembly:

ESTA intends not to publish any standard that contains protected intellectual property, unless that information can be licensed by anyone for a reasonable fee. ESTA uses a process of open patent and copyright disclosures to implement its intent. ESTA does not conduct patent or copyright searches and does not warrant that its standards contain no protected intellectual property.

In keeping with the open disclosures policy, I ask if anyone present wishes to notify this working group of the existence of a patent, patent application, copyright, or other protected intellectual property that might protect material in a standard being developed by this working group. You need not be the holder of the patent or copyright to notify this working group of its existence.

Nothing was revealed.

3 Attendance and Membership

3.1 Requirements for membership

Don Cooper read the following statement aloud to the assembly:

Membership is open to all parties who are affected by the work of the group; membership in ESTA is not a requirement, but there is a \$100/person/year participation fee to help fund the costs of running the Technical Standards Program. Voting members are required to attend meetings and vote on letter ballots. Any principal member and alternate that both miss three consecutive meetings or that miss three consecutive letter ballots will have their membership status changed to observer. This action will be taken at the beginning of the first meeting after such inaction and will be recorded in the minutes of that meeting.

3.2 Determination of a quorum

There are now 41 voting members, so a quorum is 14; a supermajority is 22.

Richard Nix confirmed that both requirements had been met.

Janine Jordan asked for clarification about "ESMP" (Event Safety Management Plan), and wanted to ensure we're not

Dominic Housiaux moved to send the revised draft out to another public review. The motion was seconded and carried without objection or abstentions. A BSR8 will be filed, with a public review commencing soon thereafter.

Dominic Housiaux said they are close to having comments resolved, and a draft revision complete. He said there was a comment that noted the word "Standard" in the foreword, noting also that the title makes no such indication. Erin Grabe said the title does sound vague. Richard Nix said that ANSI makes no distinction between standards, recommended practices, or guidelines in titles. If the document completes an ANSI accredited standards development process, it's considered a standard. Don Cooper added that, in any case, the guidance is directed by the normative words used – e.g. should, shall, must, may. Karl Ruling said it's important to follow whatever the document says to do, even if the document says it gives recommendations.

Steve Adelman moved to approve the draft as an ANS, with the title of *"Event Safety – <u>Event Security"</u>*. The motion was seconded, and will be decided by letter ballot.

6.1.12 BSR ES1.41 – Drones

It's hovering on the agenda.

Any news or updates?

Richard Nix mentioned a new effort in the EU that will cover indoor drone use. Randall Greenlee said there is a new CEN project covering this topic. He said a committee is in place, and a working group will be formed; there is only a basic idea of a structure in place, but they are just getting started. Dietmar Rottinghaus said he only knows that it is a complex problem, Randell agreed, because there are so many different stakeholders.

Don Cooper suggested that it may be best to observe what's going on internationally, to see if there is something to borrow from. Alyxzander Bear said one major issue here in the US is that there are so many different jurisdictions, so it's hard to develop consistent standards. He also mentioned there are no standards or regulations for cable supported cameras.

6.1.13 BSR ES1.42, Event Safety -- Parade Safety

The TSC approved the project, the PINS filing was completed. The Chairperson needs to appoint task group leaders and other members.

Any other news or action?

Don Cooper appointed Steve Adelman as the task group leader, and asked him to send a list of people he thinks would participate.

7 New business

Mike Weston asked about material handling, and if this working group would be the right place to bring the subject. He has seen a lot of injuries due to material handling – e.g. forklifts, stacking truss, etc. Ethan Gilson said that this topic has come before this group before. He would support it. Dominic Housiaux said he would also support this. Bryan Huneycutt said he thinks this is a modification of application of practice, not development of a new practice or standard.

There was a lot of discussion in favor of the topic. Robert Haycock said that most of the injuries at his current workplace (San Francisco Opera) are material handling injuries.

Steve Vanciel said that at his IATSE local, Local 836, in Orlando, a worker died when a load fell over and crushed him.

Bryan Huneycutt asked if this would also be a good opportunity to collaborate with ETCP resources.

Jane Harrington said she thinks this would not be a standard per se, but rather a compilation of training materials. Janet Sellery said she also thinks it's a good topic, not as a standard, but as a resource list compilation. Training material is best, in her opinion.

Jerry Gorrell said that the problem with material handling is not skills and available resources, but rather is training, site management, and hazard evaluation. He thinks trying to write a new standard for material handling is a futile effort. He thinks writing an article about it has more value to the people who are seeking advice and guidance. He noted that the single most cited OSHA violation is failure to have a competent person onsite.

Mike Weston volunteered to lead an ad hoc task group to discover the best path forward with this idea to reduce injuries and improve safety with respect to material handling in the event industry. Possible directions include gathering training resources, writing a new standard, and writing an informal guideline. Dominic Housiaux, Robert Haycock, and Steve Vanciel all volunteered to assist. Anyone else interested should contact Mike Weston directly.

8 Other business and announcements

8.1 NAMM education tracks

Robert Haycock said that he is coordinating the Health & Safety session topics for NAMM, and asked anyone with ideas or interest to reach out to him.

I was overwhelming impressed with Chris's vigilance and endurance as we worked on the rigging component of the event safety standard. A consummate and knowledgeable professional that guided as needed and pushed as needed with perfect balance. It was a pleasure to work with him and learn from his experience.

Daniel Ayers read his nomination statement in support of Dominic Housiaux's award:

Working with Dominic has been an honor and a privilege. Dominic brings a perspective to Event Safety which often goes unrecognized. I am nominating him for the leadership he has shown while drafting the Medical and Electrical standards over the past couple years. These standards truly came together because of Dominic's involvement. Dominic recognized the needs, the gaps, and the resources and coordinated with the other members to ensure the needs were met. ESTA needs more individuals like Dominic.

There was applause and congratulations to both recipients. Richard Nix noted that these were 2022 awards, which were held in an attempt to present them in-person.
