1 Opening Remarks

Don Cooper called the meeting to order at 11:03, confirming that this is the Event Safety Working Group meeting, and thanking everyone for taking time to attend today. He asked people to mute their microphones if not speaking.

2 Patent and anti-trust statements

2.1 Reading of the anti-trust statement

Don Cooper read the following statement aloud to the assembly:

ESTA and its members take seriously their obligation to comply with all applicable antitrust laws. Therefore, during this meeting and during all ESTA events, all discussions will be limited to those subjects that are permitted by the antitrust laws. All members should refrain from any discussion or mention of competitively sensitive subjects such as the current or future prices charged for any member product or services, current or

future marketing plans or strategies, and current or future costs, including employee salaries. There also must be no agreement on the suppliers or customers that members will or will not do business with or the markets in which members will conduct business.

Violations of the antitrust laws can have serious consequences. If you have any questions or concerns about anything that is discussed at an ESTA meeting, please bring your concern to ESTA management. An easy to read pamphlet describing the antitrust laws is available from the ESTA staff.

Karl Ruling held up the pamphlet in front of his camera so that attendees with video could see it.

2.2 Reading of the call for patents

Don Cooper read the following statement aloud to the assembly:

ESTA intends not to publish any standard that contains protected intellectual property, unless that information can be licensed by anyone for a reasonable fee. ESTA uses a process of open patent and copyright disclosures to implement its intent. ESTA does not conduct patent or copyright searches and does not warrant that its standards contain no protected intellectual property.

In keeping with the open disclosures policy, I ask if anyone present wishes to notify this working group of the existence of a patent, patent application, copyright, or other protected intellectual property that might protect material in a standard being developed by this working group. You need not be the holder of the patent or copyright to notify this working group of its existence.

Membership is open to all parties who are affected by the work of the group; membership in ESTA is not a requirement, but there is a \$100/person/year participation fee to help fund the costs of running the Technical Standards Program. Any principal member and alternate that both miss three consecutive meetings or that miss three consecutive letter ballots will have their membership status changed to observer. This action will be taken at the beginning of the first meeting after such inaction and will be recorded in the minutes of that meeting.

Richard Nix said that the reminders had been sent out. He asked people to please pay. If they received a reminder but had already paid, please report this. We have a new database, and we need to sort out any errors.

7 New business

7.1 Barricades or barriers

Don Cooper said that recent discussions indicate that current drafts mentioning them should maintain control of the definitions. There doesn't seem to be enough consensus to address barricades or barriers in a standalone standard.

7.2 Ballast (and material handling)

Don Cooper reminded everyone of prior discussions about ballast, which were precipitated by an incident in which a worker was killed by a ballast falling from a forklift while being placed.

Mike Aug asked if there were any standards that address material handling. Karl Ruling said that there were, especially in OSHA, but that he would do further research on this. Dominic Housiaux said that there were not standards that addressed the particular circumstances of the entertainment industry, such as ballast, or scenery elements. He said that the typical standards will address ergonomics more than material handling, lifting boxes in a warehouse.

Janet Sellery said she thought this would be a good topic for standards, because of the number of insurance claims and incidents she sees in her work. Dominic Housiaux agreed, saying he knows of at least ten deaths due to material handling accidents.

Alyxzander Bear said that one of the problems is enforcement. People do the wrong thing, are cautioned by a supervisor, and then continue with the unsafe practice.

Richard Nix said that there is talk in the ICC committees about "anchorages" which often are ballasts. There is a move in California to ban water ballasts.

Don Cooper closed the discussion by saying this might be candidate for a future project once we get the current projects completed.
