1 Opening Remarks

Jerry Gorrel called the meeting to order at 17:04 EDT. He thanked people for attending.

2 ESTA declarations

2.1 Call for patents

The following statement was read aloud to the working group by Jerry Gorrell:

ESTA intends not to publish any standard that contains protected intellectual property, unless that information can be licensed by anyone for a reasonable fee. ESTA uses a process of open patent and copyright disclosures to implement its intent. ESTA does not conduct patent or copyright searches and does not warrant that its standards contain no protected intellectual property.

In keeping with the open disclosures policy, I ask if anyone present wishes to notify this working group of the existence of a patent, patent application, copyright, or other intellectual property that might protect material in a standard being developed by this working group. You need not be the holder of the patent or copyright to notify this working group of its existence.

Nothing was revealed.

2.2 Reading of the anti-trust statement

The following statement was read aloud to the working group by Jerry Gorrell:

ESTA and its members take seriously their obligation to comply with all applicable antitrust laws. Therefore, during this meeting and during all ESTA events, all discussions will be limited to those subjects that are permitted by the antitrust laws. All members should refrain from any discussion or mention of competitively sensitive subjects such as the current or future prices charged for any member product or services, current or future marketing plans or strategies, and current or future costs, including employee salaries. There also must be no agreement on the suppliers or customers that members will or will not do business with or the markets in which members will conduct business.

Violations of the antitrust laws can have serious consequences. If you have any questions or concerns about anything that is discussed at a ESTA meeting, please bring your concern to ESTA management. An easy to read pamphlet describing the antitrust laws is available from the ESTA staff.

Karl Ruling displayed a copy of the pamphlet. No restraint of trade concerns were raised.

3 Attendance and membership

3.1 Requirements for membership

The following statement was read aloud to the working group by Jerry Gorrell:

Membership is open to all who are affected by the work of the group. Voters who would be in the designer or dealer/rental company interest category in particular are encouraged to become members. There is an annual \$100 participation fee for all members. Voting members are required to attend meetings and to vote on letter

ballots. Voting members and their alternates may not miss three consecutive meetings or three consecutive letter ballots without a loss of voting status.

3.2 Introductions of attendees

Jerry Gorrell read off the names of the people attending. They said hello.

3.3 Determination of quorum

As of 5 September 2022, there are 13 voting members. A quorum is five, a supermajority is seven.

Karl Ruling noted that eight voters were present, more than enough to pass a motion needing a supermajority

3.4 Processing of new membership and status change requests

As of 5 September 2022, there are no new applications on file, but Justin Bennett had asked to counted as an observer, not as a principal voting member. He has been removed from the consensus body.

Javid Butler says he has reviewing the CPWG's UDR draft standard, which would use this SPD data.
