## 1 Opening Remarks

#### 2 ESTA declarations

## 2.1 Call for patents

The following statement was aloud to the working group by Jerry Gorrell:

ESTA intends not to publish any standard that contains protected intellectual property, unless that information can be licensed by anyone for a reasonable fee. ESTA uses a process of open patent and copyright disclosures to implement its intent. ESTA does not conduct patent or copyright searches and does not warrant that its standards contain no protected intellectual property.

In keeping with the open disclosures policy, I ask if anyone present wishes to notify this working group of the existence of a patent, patent application, copyright, or other intellectual property that might protect material in a standard being developed by this working group. You need not be the holder of the patent or copyright to notify this working group of its existence.

Nothing was revealed.

# 2.2 Reading of the anti-trust statement

The following statement was aloud to the working group by Jerry Gorrell:

ESTA and its members take seriously their obligation to comply with all applicable antitrust laws. Therefore, during this meeting and during all ESTA events, all discussions will be limited to those subjects that are permitted by the antitrust laws. All members should refrain from any discussion or mention of competitively sensitive subjects such as the current or future prices charged for any member product or services, current or future marketing plans or strategies, and current or future costs, including employee salaries. There also must be no agreement on the suppliers or customers

that members will or will not do business with or the markets in which members will conduct business.

Violations of the antitrust laws can have serious consequences. If you have any questions or concerns about anything that is discussed at a ESTA meeting, please bring your concern to ESTA management. An easy to read pamphlet describing the antitrust laws is available from the ESTA staff.

Karl Ruling displayed one of the easy-to-read pamphlets to show that is its available.

## 6.7 BSR E1.54, ESTA Color Standard

Task group: Wendy Luedtke, Mark Primrose, and Mike Wood

Michael Wood said we are back to where we were on the 25<sup>th</sup> of October in 2018. The draft requires only the x,y coordinate to be sent. RGB color space is in for information, but it is not necessary for communicating color.

Tucker Downs commented on the NextGen Color task group meeting. They seem their job as communicating the color information that is required by E1.54.

Karl Ruling was directed to send the most recent draft of E1.54 to the working group.

#### 7 New business

7.1 Possible new project – baseline reporting of dimming curves for solid state lighting fixtures From the draft July meeting minutes:

Jerry Gorrell suggested that we need to bring more of the stakeholders to the table for a larger discussion, before voting on accepting this project. He suggested trying to target more of them specifically to attend the next Westlake meeting for further discussions. He appointed Justin Bennett, Michael Lay, and Mark Primrose to an ad hoc task group, which will collectively solicit participants for a larger focus group. The group will schedule a September WebEx meeting as

necessary, and will report back to the working group in October.

See LED\_dimming\_ProjectRequest-Copy.pdf, which has a much simplified scope from the original two LED dimming proposals. This project would need to be approved by the working group, or modified and then approved, or rejected.

Justin Bennett moved we accept the project. Seconded. There was discussion. Pete Borchetta said that we want from 5% down to 0% and also from 0% up to 5%.

Mitch Hefter reported. ANSI C137.1-2019, American National Standard for Lighting Systems—0-10V Dimming Interface for LED Drivers, Fluorescent Ballasts, and Controls

Hans Lau suggested that there are anomalies in film equipment below 10%, so the range of 0 to 10% should be covered.

The scope for the PINS shall be: The standard shall describe a way of showing the end-user or equipment specifier the low-end (10% to 0% and 0% to 10%) dimming performance of LED luminaires.

The motion carried.

Jerry Gorrell appointed a task group consisting of Javid Butler, Justin Bennett, Karl Ruling, Pete Borchetta, and Jason Osterman. Karl Ruling is to be the task group leader.
