1 Opening remarks

Bill Sapsis motioned to approve the November minutes. The motion was seconded and approved by a unanimous show of hands.

4 Call for patents, to be read aloud to the assembly

The following statement was read aloud to the assembly by Mike Wood

PLASA intends not to publish any standard that contains protected intellectual property, unless that information can be licensed by anyone for a reasonable fee. PLASA uses a process of open patent and copyright disclosures to implement its intent. PLASA does not conduct patent or copyright searches and does not warrant that its standards contain no protected intellectual property.

In keeping with the open disclosures policy, I ask if anyone present wishes to notify the Technical Standards Council of the existence of a patent or copyright or other intellectual property that might protect material in a standard being developed by a working group. You need not be the holder of the patent or copyright to notify the Technical Standards Council of its existence.

5 Anti-trust statement, to be read aloud to the assembly

The following statement was read aloud to the assembly by Mike Wood:

The PLASA Board of Directors and the leadership of this Technical Standards Council will reject or nullify any actions that unlawfully restrain trade. Anyone who feels that such an action is being or has been taken is requested to bring that matter to the attention of the chair immediately. Anyone who feels that actions in restraint of trade have been taken and not properly annulled is requested to notify the PLASA Chair immediately.

PLASA legal counsel has informed us that violations of the anti-trust laws can have serious consequences. Individuals engaged in certain unlawful conduct can be found criminally liable. An individual convicted of a criminal violation of the Sherman Act may be fined as much as \$1,000,000 and imprisoned for up to ten years. An easy to read pamphlet describing restraint of trade issues is available from the Technical Standards Manager.

8 Old business and standing reports

8.1 Financial reports

8.1.1 Treasurer's Report and Status of Contributions and Pledges

Lori Rubinstein gave the treasurer's report. The crucial item is the ProSight sponsorship, which renewal of is unknown at this time. There should be a firm decision by March if they intend to renew. Lori Rubinstein noted that conversations with ProSight have seemed positive and that they have been using PLASA as a business resource. One move on their part, Lori Rubinstein noted, was that ProSight had hired an association relationship manager, which suggests that they are serious about working with associations such as PLASA, where they are already collaborating on possible sponsorships in Europe.

A projected deficit of \$100,000 is faced by this organization. Donations have dropped, and the ProSight sponsorship is uncertain.

Alan Rowe was asked if IATSE Crafts Advancement Program (ICAP) representatives could attend the next ad hoc marketing meeting, which is scheduled for Wednesday 26 March 2014, from 7pm-11pm at the Hilton Fort Worth. The answer was Yes.

8.2.2.2 Making the TSP be more international

The task group is planning a dress rehearsal for January, with Ron Bonner as the test subject on the other end. Dependent upon the outcome, we will schedule an "opening night" for the July meetings.

Erin Grabe apologized that the subscription was not on line for this meeting cycle. The plan is to have it happen before the March meetings, with time for PLASA administration to work with it beforehand.

10 Optional Reports

10.1 Optional reports by working and task group leaders on active projects

10.1.1 Control Protocols

Mike Lay positively reported on the work load. Bill Ellis and Simon Newton were given Above and Beyond awards.

Steve Terry reported that ETC has received feedback on users wanting RDM shut off by default, though the features are enabled to support plug and play setup. There was talk about publishing an article that clearly lays the blame for flickering lights when non DMX512 data is present on sloppy implementations of DMX512 that do not check the START Code.

A link from tsp.plasa.org/rdm to rdmprotocol.org was requested. The consensus was to link with a required "This link will take you to a third-party site, not endorsed by PLASA. . . . " type of disclaimer

visible near the link. Steve Terry moved that the link be approved with the disclaimer. The motion was seconded and approved by a show of hands.

Mike Wood reported on an ad hoc meeting at PLASA of console manufacturers, with many major manufacturers in attendance. The problem of maintaining fixture libraries was the topic of conversation. The interested parties are happy to share fixture DMX512 personalities with each other, provided that all participants add their information. Mike Wood suggested that we could host this data base easily.

Eddie Kramer moved that Mike Wood continue to work as our representative to this ad hoc committee. The motion was seconded and approved by a show of hands. Consensus of the group was that we were open in principle to hosting a database of DMX512 personalities.

10.1.2 Electrical Power

Mitch Hefter reported:

- Task group moving forward on the grounding and bonding for portable structures draft
- A 19-pin circular connector draft was in process, but add'l assistance was needed and requested
- E1.51 to be offered for letter ballot for public review
- Steve Terry was given the Above and Beyond Award.
- Roger Lattin noted that there was discussion of a possible RP for Class C GFCI.

10.1.3 Floors

Jerry Gorrell reported:

- Working on the stage edge recommended practice with intent of public review vote at USITT
- Reaffirmation of slipperiness standard

10.1.4 Fog and Smoke

Larry Schoeneman reported that two documents for reaffirmation are in public review. The group will meet at USITT.

10.1.5 Followspot Position

No news from this group in maintenance mode.

10.1.6 Photometrics

Jerry Gorrell reported on a possible project for a common language for color specification. This is an idea that has been floated in *Protocol*.

Mike Wood said that Robert Bell had called him and expressed interest. Other key parties also are interested.

10.1.7 Rigging

Bill Sapsis reported on a good, productive meeting:

- Above and Beyond Awards given to Christine Kaiser and Dan Culhane
- Reported that E1.39 was revised and will be offered for public review, with vote in March
- Video wall project—Charlie Weiner could not attend to offer an update
- · Bill Sapsis noted that he hoped the working group might get smaller as projects are completed
- Sapsis moved that the Technical Standards Council approve a revision of E1.22.

The motion to approve an E1.22 revision project was seconded and then approved by a show of hands.

10.1.8 Stage Lifts

Erin Grabe reported that the group had resolved the comments from the last public review. They are in the process of approving the comment resolution summary and the affected document with the intent of another public review.

10.2 Reports of affiliated organizations and PLASA EU

10.2.1 ASTC

Jules Lauve reported that Ned Lustig has stepped down as secretary and that R. Duane Wilson has stepped in. The body will meet at USITT and is working on the Student-Consultant Theoretical Renovation Challenge with USITT. Jules Lauve explained that four projects are to be presented at the USITT Conference.

Lauve reported that Gene Leitermann has stepped down from leading Theatre Projects Consultants, and that there has been an advertisement for a General Manager/COO. David Rosenberg is the Managing Partner fulfilling many of the General Manager/COO duties right now.

10.2.2 NFPA

10.2.2.1 FDW-AAA committee

Jerry Gorrell reported on the committee's work on NFPA 80, fire doors and protectives. He said that there is a problem with companies selling fire resistant curtains that comply with UL 10D as theatre fire safety curtains. However, the UL 10D specification is too light-weight for theatre fire safety curtains. They comply with a UL standard, but not the right UL standard for the application.

10.2.2.2 SPE-AAA

Larry Schoeneman reported on the hybrid effects issue in which gas effects can be done under the pyro standard. He said that he voted against the motion.

10.2.2.3 SAF-AXM

Jerry Gorrell reported that a meeting notice is expected soon.

10.2.3 PLASA EU

No report was distributed. Lori Rubinstein had nothing. Ron Bonner sent no report.

10.2.4 USITT

11 Other business

11.1 Rigging International Code of Practice

Lori Rubinstein reported that progress was being made on compiling an International Code of Practice, a summary of what standards, regulations, and consensus work practices apply where at various places around the world.

11.2 HVAC

Actually, not "HVAC" but an ASHRAE interest in measuring stage lighting power consumption so that ASHRAE standards would have a better foundation for energy management in performance spaces. Steve Rust had put together a meeting between himself, Dennis Wessel of Karpinski Engineering (the ASHRAE representative), and Karl Ruling at LDI. A formal proposal for a study may come of this, but not yet.

Mike Wood and Steve Terry reported that the estimation method used in Katie Oman's *Protocol* article has been verified and works with reasonable accuracy. It is much easier and much safer to do than measuring actual power consumption at the inputs to theatre lighting systems.

11.3 Above & Beyond Award

Michael Lay reported that it was a nice morale boost. He suggest we do it every year. We will leave the nomination form available all year on the website.

Move it to the USITT meeting? Steve Terry moved that it be in January. The motion was seconded by discussion, and then approved with a show of hands.

11.4 Richard Cadena request

From the draft November minutes:

Steve Terry moved that we allow the request with the provision that:

- 1. The entire annex be reproduced with the notes
- 2. That the standard and the edition be referenced.
- 3. That we have the right to review and to give final approval of the usage of the excerpted material from the standard.

The revised motion was seconded and approved by a show of hands.

Richard Cadena has been made aware of this group's decision and agreed to send a draft layout when available. Karl Ruling reported that there was no further communication with Richard Cadena since the request with provision was acknowledged. Mitch Hefter reported that the book is due to be published next month.
