1 Opening remarks

Mitch Hefter called the meeting to order at 15:04. Explained that Justin Bennett is teaching a class, so he will be leading the meeting. He thanked everyone for their attendance, and reminded everyone to mute their microphones when not speaking.

2 Patent and anti-trust statements

2.1 Reading of the anti-trust statement

Mitch Hefter read the following statement aloud to the assembly:

ESTA and its members take seriously their obligation to comply with all applicable antitrust laws. Therefore, during this meeting and during all ESTA events, all discussions will be limited to those subjects that are permitted by the antitrust laws. All members should refrain from any discussion or mention of competitively sensitive subjects such as the current or future prices charged for any member product or services, current or future marketing plans or strategies, and current or future costs, including employee salaries. There also must be no agreement on the suppliers or customers that members will or will not do business with or the markets in which members will conduct business.

Violations of the antitrust laws can have serious consequences. If you have any questions or concerns about anything that is discussed at an ESTA meeting, please bring your concern to ESTA management. An easy to read pamphlet describing the antitrust laws is available from the ESTA staff.

A copy of the pamphlet was displayed by Karl Ruling. No concerns were reported.

2.2 Reading of the call for patents

Mitch Hefter read the following statement aloud to the assembly:

ESTA intends not to publish any standard that contains protected intellectual property, unless that information can be licensed by anyone for a reasonable fee. ESTA uses a process of open patent and copyright disclosures to implement its intent. ESTA does not conduct patent or copyright searches and does not warrant that its standards contain no protected intellectual property.

In keeping with the open disclosures policy, I ask if anyone present wishes to notify this working group of the existence of a patent, patent application, copyright, or other protected intellectual property that might protect material in a standard being developed by this working group. You need not be the holder of the patent or copyright to notify this working group of its existence.

No protected IP was reported.

3 Attendance and Membership

3.1 Requirements for membership

Mitch Hefter read the following statement aloud to the assembly:

Membership is open to all parties who are affected by the work of the group; membership in ESTA is not a requirement, but there is a \$100/person/year participation fee to help fund the costs of running the Technical Standards Program. Voting members are required to attend meetings and vote on letter ballots. Any principal member and alternate that both miss three consecutive meetings or letter ballots will have their membership status changed to observer. This action will be taken at the beginning of the first meeting after such inaction and will be recorded in the minutes of that meeting.

3.2 Introduction of attendees and taking attendance.

3.3 Determination of quorum

After counting voting attendees, Richard Nix reported that more than 50% of the voting body was present, enough to pass a motion needing a supermajority.

3.4 Processing of new and other membership requests

Kevin Amick requested change of status back to Principle voting. Ian Folds moved to approve the change. The motion was seconded and carried without objection or abstentions.

3.5 Changes to observer status due to lack of participation

Steve Brock, Guardian Entertainment Inc., had missed the previous two meetings and was not present for this meeting. He was moved to observer status.

6.1 ANSI E1.16 – 2002 (R2017) Entertainment Technology – Configuration Standard for Metal Halide Ballast Power Cables

The document is in public review for reaffirmation with a concurrent letter ballot until 05 October 2021. Karl Ruling reported no public review comments so far.

6.2 BSR E1.19, Recommended Practice for the Use of Class A Ground-Fault Circuit Interrupters (GFCIs) Intended for Personnel Protection in the Entertainment Industry (Revision of the 2015 edition)

Task group: Justin Bennett, one representative from Lex (Bob Luther or John Valus Jr.), Ian Foulds, Nehad El Sherif, Mike Skinner, one representative from I.A.T.S.E. Local 728 (Alan Rowe), and one representative from I.A.T.S.E. Local 891 (Keith Woods or Simon Hunt).

8.2 IES report

Mitch Hefter said the IES has lots of projects. He's working on the controls narrative project, with a meeting on that topic later this week.

8.3 NEC report

NEC task groups are meeting now, reported Mitch Hefter, which is why we are missing Steve Terry and Wendy Russell from this EPWG meeting. Steve Terry is now the USITT Alternate for Code Making Panel 15 and Wendy Russell is the Principal. Hefter has been nominanted to be Terry's Alternate on CMP 13. Bill Ellis has been nominated to be Jason Potterf's Alternate for ESTA on CMP 18.

Jason Potterf reported that some progress was being made on class 2 wiring for emergency lighting, keeping the requirements reasonable (e.g., not requiring Ethernet patch cords to be in metal conduit). He noted interest in cybersecurity for networked devices being pushed by NRTLs. No cybersecurity requirements are written into the NEC yet, but there is push for this, which would make a market for NRTLs to certify products.

Hans Lau complained about the TerraView tool that must be used to view and comment on NFPA documents.

8.4 USITT

Mitch Hefter reported that planning is underway for the Conference to be held in March 2022. It will be a hybrid event. He also reported that the USITT is revising its bylaws to fit NY state law. "Vice President" titles are to be removed, but the tasks will be done by someone.
