1 Opening remarks

4 Reading of the call for patents

The following statement was read aloud to the assembly by Mitch Hefter:

ESTA intends not to publish any standard that contains protected intellectual property, unless that information can be licensed by anyone for a reasonable fee. ESTA uses a process of open patent and copyright disclosures to implement its intent. ESTA does not conduct patent or copyright searches and does not warrant that its standards contain no protected intellectual property.

In keeping with the open disclosures policy, I ask if anyone present wishes to notify this working group of the existence of a patent, patent application, copyright, or other intellectual property that might protect material in a standard being developed by this working group. You need not be the holder of the patent or copyright to notify this working group of its existence.

Nothing was revealed.

5 Reading of the anti-trust statement

The following statement was read aloud to the assembly by Mitch Hefter:

ESTA and its members take seriously their obligation to comply with all applicable antitrust laws. Therefore, during this meeting and during all ESTA events, all discussions will be limited to those subjects that are permitted by the antitrust laws. All members should refrain from any discussion or mention of competitively sensitive subjects such as the current or future prices charged for any member product or services, current or future marketing plans or strategies, and current or future costs, including employee salaries. There also must be no agreement on the suppliers or customers that members will or will not do business with or the markets in which members will conduct business.

Violations of the antitrust laws can have serious consequences. If you have any questions or concerns about anything that is discussed at an ESTA meeting, please bring your concern to ESTA management. An easy to read pamphlet describing the antitrust laws is available from the ESTA staff.

Richard Nix held up an easy-to-read pamphlet. No antitrust issues were brought forth.

7.5 BSR E1.51, A Canadian E1.18

Update on status.

The BSR9 form for final acceptance has been filed with ANSI, Ruling reported. There has been no response yet from ANSI staff other than an acknowledgment of the submission.

7.6 BSR E1.53 – 2016, Overhead mounting of luminaires, lighting accessories, and other portable devices: specification and practice

It's in public review, Ruling reported.

7.7 ANSI E1.58 – 2017, **– Indoor equipment outdoors** (Reaffirmation, revision, or withdrawal by 11 October 2022)

No action or news at this time.

7.8 BSR E1.65, Recommended practice for the periodic inspection, testing, and maintenance of Electrical and Electronic equipment used in the entertainment and live event industries

"This standard will establish the minimum requirements for periodic inspection and maintenance of electrical systems and equipment used in the entertainment and live event industries. It is intended to complement, not replace, the guidance offered in NFPA 70E, NFPA 70B, NFPA 78, and equipment manufacturers' instructions." Status update.

Eddie Kramer reported on recent task group meetings. Steve Terry posed a series of questions to help clarify scope, and there was discussion.

- What is the intended audience? The consensus was that perhaps the most appropriate audience is facility managers and operators, both qualified and unqualified.
- Would it be used for training?
- What types of equipment are in its scope? The consensus was that both permanent & portable production equipment could be included.
- What's excluded?
- Terry suggested a 600 V upper limit, since some power distribution is at 480 volts.

- Is there potential for procedural complexity?
- Terry suggested that the problem to be solved should be in the scope.

A task group meeting is scheduled for Anaheim, during the NAMM meeting cycle. Both Justin Bennett and Mitch Hefter were added to the task group and its email reflector, <u>e1-65@esta.org</u>.

7.9 Multiconductor cable project

At the last meeting, Steve Terry moved to defer the project due to insurmountable technical issues. He has a proposed solution.

There was discussion of Steve Terry's proposal (NEC 2023 Proposal Multi-Circuit Cable Systems.pdf).

Eddie Kramer proposed we develop a guidance document on cable marking, congruent with point 6 in Steve Terry's proposal, stating to the effect that "All multi-circuit, multipole connectors shall be clearly marked with the voltage of the branch circuits serviced by the connector." This was not taken up as a new work project.

Mitch Hefter asked working group members to submit comments on Terry's proposal to Steve Terry.

9 Other business and announcements

Roger Lattin said that someone in his Local had expressed concern about a correlation between EMF radiation and cancer. The concern initially expressed was about the low-frequency radiation of electrical power distribution, but the gist of the conversation was that people thought higher frequency radiation is more likely to be a health concern.

Jerry Gorrell moved that we refer the concern about non-ionizing electromagnetic radiation as a possible carcinogen to the USITT's Safety and Health Commission. The motion was seconded, and carried without opposition.
