1 Opening Remarks

Chris Kaiser called the meeting to order at 11:01, wishing everyone a good morning.

2 Patent and anti-trust statements

2.1 Reading of the anti-trust statement

Chris Kaiser read the following statement aloud to the assembly:

ESTA and its members take seriously their obligation to comply with all applicable antitrust laws. Therefore, during this meeting and during all ESTA events, all discussions will be limited to those subjects that are permitted by the antitrust laws. All members should refrain from any discussion or mention of competitively sensitive subjects such as the current or future prices charged for any member product or services, current or future marketing plans or strategies, and current or future costs, including employee salaries. There also must be no agreement on the suppliers or customers that members will or will not do business with or the markets in which members will conduct business.

Violations of the antitrust laws can have serious consequences. If you have any questions or concerns about anything that is discussed at an ESTA meeting, please bring your concern to ESTA management. An easy to read pamphlet describing the antitrust laws is available from the ESTA staff.

Karl Ruling held up the pamphlet in front of his camera for all video enabled attendees to see.

2.2 Reading of the call for patents

Chris Kaiser read the following statement aloud to the assembly:

ESTA intends not to publish any standard that contains protected intellectual property, unless that information can be licensed by anyone for a reasonable fee. ESTA uses a process of open patent and copyright disclosures to implement its intent. ESTA does not conduct patent or copyright searches and does not warrant that its standards contain no protected intellectual property.

In keeping with the open disclosures policy, I ask if anyone present wishes to notify this working group of the existence of a patent, patent application, copyright, or other protected intellectual property that might protect material in a standard being developed by this working group. You need not be the holder of the patent or copyright to notify this working group of its existence.

Membership is open to all parties who are affected by the work of the group; membership in ESTA is not a requirement, but there is a \$100/person/year participation fee to help fund the costs of running the Technical Standards Program. Any principal member and alternate that both miss three consecutive meetings or that miss three consecutive letter ballots will have their membership status changed to observer. This action will be taken at the beginning of the first meeting after such inaction and will be recorded in the minutes of that meeting.

Steve Walker expressed concern for the proposed resolution to comment 3. There was discussion, resulting in a small change to the draft standard's text, and a simplified comment resolution, as follows:

Accept in principle. Change the first sentence of the clause to state, "When attaching blocks to non-metallic materials, the anchorage method shall be approved by a qualified person..."

Richard Nix amended the motion to include the revised comment resolution. The motion carried unanimously.

Richard Nix moved to accept the draft as revised per today's working group's discussion. The motion was seconded and carried unanimously.

Richard Nix then moved to send the revised draft to second public review. The motion was seconded and carried without objection or abstentions. A BSR8 will be filed with ANSI.

First, he thanked the task group for all of their hard work, explained how the original E1.6-4 had been split between two new drafts, which had been sent to the working group for this meeting, then moved to send both of the drafts to first public review. Three factors might compel the working group to consider reopening the standard for revision:

First, there has been previous discussion within the RWG about harmonizing weather hazard mitigation requirements from the ESWG's Weather Preparedness standard with the OMP requirements of E1.21. ANSI ES1.7 – 2021 is now published, so that correlation will become immediately useful.

Second, there are current code change proposals within the International Building Code seeking to correlate with the IFC, but which also include a reference to ANSI ES1.7. Currently, the IFC does not reference ES1.7, but the developers would – presumably - welcome such a reference, especially if it is supported by the IBC. Including it as a reference in E1.21 will only bolster such an approval.

Third, the current IBC proposal is part of a longer-term, 3-step process by ASCE to overhaul ASCE 7, and ASCE 37. Their mid-term goal is to write an explicit statement in the next revision of ASCE 37, prohibiting its use for anything other than buildings under construction. Opening E1.21 for revision will present an opportunity to invite ASCE's input as a gesture of collaboration towards achieving mutually acceptable requirements.

On the merits of the explanation provided in the agenda, Richard Nix asked if there were any questions, then moved to open the standard for revision. The motion was seconded, and carried without objection or abstentions.

Chris Kaiser asked if the previous task group members remained intact and willing. Richard said yes, provided the names of the task group members, then asked for a few more volunteers who would be specifically interested in the integration of ES1.7. After discussion, Chris Kaiser appointed the following task group members: Richard Nix (leader), Bill Gorlin, Dan Louis, Sandy Gilzow, Kyle Kusmer, Elmer Veith, Ryan Riordan, Joe Golden, Shawn Nolan, and Allen Winzler.

The task group has sent a progress draft containing notes and questions, along with an explanatory document regarding their current approach, for working group discussion.

Eric Rouse reported, saying that the current update was a preview of what they hope to achieve by the June meeting cycle. Then, he thanked his task group for their talent, patience, and effort. He went through the points in the "Approach" document, and asked the working group at-large for an informal review and comment, so that they can work towards a completed draft in time for the June meeting.

Key points in the task group's approach include considerations for "proven service designs", by adding provisions for manual flying systems, and making the overall requirements more applicable to smaller productions. They will expand the standard's applicability to a wider audience, so it's applicable to non-dramatic flying, such as circus performance, and they will also reorganize the standard to be more user-friendly.

Chris Kaiser commented that the supplemental approach document was very well organized, and very helpful towards understanding their path. Several others agreed.
