# 1 Opening Remarks

Dan Culhane called the meeting to order at 11:06, thanking everyone present for taking time from their busy schedules to attend, and help us move our agenda forward.

# 2 Patent and anti-trust statements

#### 2.1 Reading of the anti-trust statement

Dan Culhane read the following statement aloud to the assembly.

ESTA and its members take seriously their obligation to comply with all applicable antitrust laws. Therefore, during this meeting and during all ESTA events, all discussions will be limited to those subjects that are permitted by the antitrust laws. All members should refrain from any discussion or mention of competitively sensitive subjects such as the current or future prices charged for any member product or services, current or future marketing plans or strategies, and current or future costs, including employee salaries. There also must be no agreement on the suppliers or customers that members will or will not do business with or the markets in which members will conduct business.

Violations of the antitrust laws can have serious consequences. If you have any questions or concerns about anything that is discussed at an ESTA meeting, please bring your concern to ESTA management. An easy to read pamphlet describing the antitrust laws is available from the ESTA staff.

Karl Ruling held up the pamphlet, in front of his camera, for all present to see.

# 2.2 Reading of the call for patents

Dan Culhane read the following statement aloud to the assembly.

ESTA intends not to publish any standard that contains protected intellectual property, unless that information can be licensed by anyone for a reasonable fee. ESTA uses a process of open patent and copyright disclosures to implement its intent. ESTA does not conduct patent or copyright searches and does not warrant that its standards contain no protected intellectual property.

In keeping with the open disclosures policy, I ask if anyone present wishes to notify this working group of the existence of a patent, patent application, copyright, or other protected intellectual property that might protect material in a standard being developed by this working group. You need not be the holder of the patent or copyright to notify this working group of its existence.

Nothing was revealed.

# 3 Attendance and Membership

# 3.1 Requirements for membership

Dan Culhane read the following statement aloud to the assembly.

Membership is open to all parties who are affected by the work of the group; membership in ESTA is not a requirement, but there is a \$100/person/year participation fee to help fund the costs of running the Technical Standards Program. Voting members are required to attend meetings and vote on letter ballots. Any principal member and alternate that both miss three consecutive meetings or that miss three consecutive letter ballots will have their membership status changed to observer. This action will be taken at the beginning of the first meeting after such inaction and will be recorded in the minutes of that meeting.

There are presently 25 possible votes. A quorum is 9, a supermajority is 13.

Richard Nix confirmed that both requirements have been met.

# 6.1 BSR E1.42-201x, stage and orchestra lifts

The draft's first public review closed on 06 December 2022. The public review comment summary has been distributed.

# Any updates or actions?

Steve Walker reported that they had received public review comments along with additional comments, outside of the review, from Robert Haycock. The task group will meet later this week to begin resolutions. He asked people to look at comment 19, consider those comments, and offer advice. It's about controls, and the larger working group may have more expertise on controls than the task group. Joseph Jeremy said that the intent of this comment is to bring the controls section more into line with the BSR E1.64 draft, in progress.

Dan Culhane asked people to take the request for consideration and advice on the comments seriously. This could shorten the development process by obviating a public review that nets only working group comments. Karl Ruling spoke about the importance of having these comments come from, and discussed within, the working group before the public review, rather than after or during. He said that it saves time for both ESTA and ANSI staff.

Steve Serafin asked if anyone had comments on the version that had been distributed for this meeting. Dan Culhane and Dan Lisowski noted formatting issues in 1.2, 4.1, and 5.5.8. During discussion, Matt Jordan brought up several questions about wording in 5.3.4, 5.4.4.7, 5.5.2.3, 5.5.4, and 5.5.8. In addition, 29 CFR 1910.212 was added to the list of reference documents, and the reference to ANSI E1.47 was deleted.

After discussion, Steve Serafin moved to approve the comment resolutions. The motion was seconded, and carried without objection or abstention.

Steve Serafin then moved to send the latest revision out to another public review. The motion carried without objection or abstention. A BSR 8 will be filed with ANSI, and the public review will commence soon thereafter.
